



Coloring Contest Official Rules – Youth Week 2019

1. **No purchase is necessary to enter or win.**
2. **Eligibility:** All Meritus Credit Union ("Credit Union") youth members in good standing, who are 12 years or younger, and U.S. residents. Three winners will be chosen from each of the following age groups. Participant must be 12 or under on April 18, 2019.
 - a. Group 1: Ages 0-3
 - b. Group 2: Ages 4-6
 - c. Group 3: Ages 7-9
 - d. Group 4: Ages 10-12
3. **Contest Period:** Begins on Monday, April 15, 2019 at 8:30 am (CT) and ends on Thursday, April 18, 2019 at 5:00 pm (CT), and applies only to fully complete coloring sheet submissions.
4. **To Enter:** Print and color the Youth Week 2019 coloring sheet available at merituscu.net/youthweek. Complete the entry form on the coloring sheet and enter it in one of two ways: 1. Deliver the coloring sheet to any branch. 2. Mail the coloring sheet to Meritus CU Coloring Contest, Marketing Department, 515 Guilbeau Road, Lafayette, LA 70506 and must be postmarked by April 18, 2019. All art work submitted on the coloring sheet must be only that of the entrant. Limit one entry per person.
5. **Prizes:** Contest entries will be judged by a Meritus CU employee and the prizes awarded in each age category at its sole discretion. Judging will be finalized and winners will be announced and notified by phone no later than May 3, 2019. Judge's decision is final and no correspondence will be entered into. Entries will be separated into 4 age groups. 3 prizes will be awarded per group. There will be 12 winners. Each winning entry will be awarded one (1) monetary prize (value \$15-\$25). 3rd Place winners will receive a cash prize of \$15, 2nd Place winners will receive a cash prize of \$20, and 1st Place winners will receive a cash prize of \$25. Only winners of the contest will be notified by phone and/or mail. The Credit Union is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winner(s). If a selected winner cannot be contacted by phone and/or mail provided on the entry within 14 days of drawing or is ineligible to win, prize may be awarded to an alternate winner.
6. **Entrant Agreement:** Participation in drawing constitutes full and unconditional agreement of legal parent or guardian to, and acceptance, of these Official Rules. Prize(s) will be awarded only if entrants comply with these Official Rules.
7. **Eligibility Exceptions and General Terms:** Employees of the Credit Union, members of the Board of Directors and volunteer officials, and their immediate family members are ineligible. Sweepstakes void where prohibited by law. All federal, state and local laws and regulations apply. No cash or other consideration will be paid and winners are responsible for any applicable taxes or other expenses related to any prize awarded.
8. **Consumer Disclosure:** The sponsor of the Youth Week 2019 Coloring Contest is Meritus Credit Union, 515 Guilbeau Road, Lafayette, LA 70506. Odds of winning depend on the number and skill of eligible entrants. The Credit Union will award a total of approximately \$240.00 in prizes (see prizes).
9. **Release of Claims:** The winner, members of the winner's household, relatives and persons who use any prize awarded by Meritus Credit Union, and such persons heirs, assigns, executors, and administrators release and exempt Meritus Credit Union and its directors, officers, employees and agents from any and all claims, actions, demands, chooses in action and damages which they have now or any time in the future arising from use of any prize, including personal injury or death.
10. **Publicity:** By accepting a prize, winner consents to the use of his/her name and photograph or likeness for advertising and promotional services without additional compensation. The winner's name and/or likeness can be used by the Credit Union in any news release, advertisement or other Credit Union communications without further compensation or consideration, the prize awarded being deemed sufficient consideration for all terms and conditions. The Credit Union may copyright and use, reuse, publish and republish the winner's picture, portrait or other likeness, character, characterization or form with the winner's name in any media for any reasonable purpose, including any printed matter prepared by/for or distributed by/for the Credit Union without any prize winner inspection or approval of any publication, advertisement, copy or other printed matter or its use by or for the Credit Union. The winner releases any liability, claims, actions, demands, and damages relating to any publication, distortion, blurring, alteration, optical illusion, or use in composite form or otherwise that may occur or be produced intentionally or otherwise, even should this subject the undersigned to ridicule, scandal, reproach, scorn or indignity.
